SUA SPONTE ORDER OF THE COURT

THIS MATTER having been brought to the attention of the Court on behalf of the Rankin County Board of Supervisors concerning the need to relocate the "Official Public Notice Posting Board" that is currently located at the Southeast Front Door of the Original Rankin County Courthouse constructed in 1925 located at North Timber Street in Brandon, Mississippi (the "Original Courthouse"); and this Court being advised in the premises that the Original Courthouse has been vacated and no longer serves as a Courthouse; and this Court finding that it is appropriate to relocate the Official Public Notice Posting Board so that it is maintained in the "... Courthouse of the County ..." as contemplated in Miss. Code Ann. Section 89-1-55 and in cases contemplated by Section 111 of the Constitution of the State of Mississippi or in any other circumstance where the posting of public notice is required; and this Court finding that the Rankin County Justice Center located at 215 East Government Street, Brandon, Mississippi, is a suitable and proper location for placement of the Official Public Notice Posting Board for Rankin County, Mississippi, inasmuch as said public building serves as the facility housing the Rankin County Circuit Court and County Court for Rankin County;

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that, effective September 1, 2022, and continuing thereafter until further Order of the Court, and following adoption by the Rankin County Board of Supervisors of an appropriate Board Order relocating the Official

Public Notice Posting Board from the Original Courthouse to the Rankin County Justice Center,
215 East Government Street, Brandon, Mississippi. The Official Public Notice Posting Board shall
be placed in the main lobby of the Rankin County Justice Center in such a way that the public is
able to access same and same is maintained accordingly;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, effective September 1, 2022, and continuing thereafter until further Order of the Court, all sales of land pursuant to Court decree or under execution and all sales of land under mortgages or deeds of trust shall be conducted at public outcry at the South-Facing Front Entry, Rankin County Justice Center, 215 East Government Street, Brandon, Mississippi;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Rankin County Board of Supervisors shall cause adequate notice of the relocation of the Official Public Notice Posting Board to the public in an acceptable manner as determined in the sole discretion of the Board of Supervisors. Said public notice should reference the effective date of the relocation and should encourage the public to make preparations for the change in location as herein set forth.
